#### Program Overview

The Medical Dental Collaboration initiative engages health care delivery systems in implementing oral health preventive services. This program is run by the Washington Dental Service (WDS) Foundation. The program targets primary care medical providers serving patients at particular risk for complications related to oral disease, including children, older adults, people with diabetes, and pregnant women. The program's goal is to catch oral disease earlier by providing oral health preventive services during well visits to primary care. These services include (but are not limited to) risk assessment for oral disease, screening for signs of oral disease, client education, and referrals to dentist offices. The program provides oral health clinical training for primary care teams, support for workflow optimization, resources such as client education materials, and assistance developing referral relationships with dental providers.
